**RESOLUTION OF THE BOARD OF SUPERVISORS OF MONROE TOWNSHIP,
CUMBERLAND COUNTY, PENNSYLVANIA, ACCEPTING A PORTION OF KUHN ROAD
AS LOCATED IN WHITE ROCK ACRES – SECTION “M”**

WHEREAS, Monroe Township has been requested by Penn Products Corporation, a Pennsylvania Corporation, to accept the dedication, as a public road, a portion Kuhn Road, same being located in White Rock Acres – Section “M”, prepared by Russell Harold Smith, RPLS, and dated July 6, 2006, also being portions of Kuhn Road as shown on plan titled “Final Plan of Section ‘M’, White Rock Acres”, prepared by Robert E. Stiffler, a Registered Surveyor, dated May 29, 1979, last revised March 25, 1980, and recorded in the Office of the Recorder of Deeds in Cumberland County, Plan Book 39, Page 25, bounded and described in the attached Deed; and

WHEREAS, said road and appurtenant structures and municipal improvements have been completed in accordance with the applicable standards of Monroe Township; and

WHEREAS, the Deed of Dedication describing a portion of Kuhn Road has been prepared and executed, said Deed of Dedication being dated July 16, 2013, a copy of which is attached hereto, marked Exhibit “A” and incorporated herein. Said Deed to be recorded in the Recorder of Deeds Office in and for Cumberland County, Pennsylvania; and

WHEREAS, Monroe Township is willing to accept the offer of dedication of a portion of Kuhn Road as so described herein.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Monroe Township, Cumberland County, Pennsylvania, as follows:

1. Monroe Township accepts a portion of Kuhn Road, being described in the Deed of Dedication which is attached hereto, marked Exhibit “A” and incorporated herein, as a public road in Monroe Township.
2. The Secretary of Monroe Township is directed to record or cause to be recorded a true and correct copy of this Resolution in the Cumberland County Court of Quarter Sessions, Clerk of Courts Office.


