**RESOLUTION 2019-16**

**RESOLUTION ESTABLISHING THE CURRENT FIRE HYDRANT  
ASSESSMENT RATES AND AUTHORIZING  
CUMBERLAND COUNTY TO PREPARE THE  
BILLING STATEMENTS THEREFORE**

WHEREAS, the Board of Supervisors of Monroe Township by Ordinance 06-2, enacted June 8, 2006, established certain assessment rates for fire hydrants and

WHEREAS, Monroe Township is desirous of contracting with Cumberland County to have the County prepare the billing statements for the fire hydrant tax; and

WHEREAS, this Resolution and the objections leading to its enactment are authorized by "The Second Class Township Code", Act of May 1, 1933, P.L. 103, No. 69, reenacted and amended November 6, 1996, P.L. 350, No. 60 (53 P.S. Section 65101, et.seq.)

NOW, THEREFORE be it resolved by the Board of Supervisors of Monroe Township, Cumberland County, Pennsylvania, as follows:

1. Effective January 1, 2020 the assessment rate for fire hydrants will be as follows:

an annual assessment is hereby levied and assessed for the cost of fire protection by an equal assessment upon all property, whether or not exempt from taxation by existing law, within seven hundred and eighty (780') feet of any fire hydrant based upon the assessment of property for county real estate tax purposes. Any property subject to the fire hydrant assessment shall bear an equal assessment as established by the annual and/or monthly cost to maintain such fire hydrant located within seven hundred and eighty (780') feet of the real property, pursuant to and proportionately to the assessment of the property for county real estate tax purposes.
2. Cumberland County is hereby authorized to prepare the billing statements for the fire hydrant tax utilizing the following methods for payment: two (2%) percent discount if the fire hydrant tax is paid during the first two (2) months; face value payment for a two (2) month period; ten (10%) percent penalty to be added after four (4) months.

3. The Secretary of Monroe Township is directed to compute any and all necessary assessments for fire hydrants within Monroe Township and shall file same, along with a true and correct copy of this Resolution, with the Monroe Township Tax Collector and with Cumberland County.


