

RESOLUTION 2020-06

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF MONROE TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA, TO IMPLEMENT ACT 15 OF 2020'S PROPERTY TAX RELIEF PROVISIONS PROVIDING REAL PROPERTY TAX RELIEF FOR THE PAYMENT OF TOWNSHIP REAL ESTATE, STREET LIGHT, FIRE HYDRANT AND FIRE SERVICE TAXES DUE TO THE COVID-19 DISASTER EMERGENCY.**

A RESOLUTION of the Board of Supervisors of Monroe Township to implement provisions of Act 15 of 2020 relating to property tax relief.

WHEREAS, Act 15 of 2020 permits taxing districts, including townships, that impose taxes on the assessed value of real property to provide relief to taxpayers;

WHEREAS, property taxes within the Township that are based upon the assessed value of real property include real estate, street light, fire hydrant and fire services taxes;

WHEREAS, on or about April 29, 2020 the Board of Commissioners of Cumberland County, Pennsylvania passed Resolution 2020-14 addressing property tax relief for the payment of county taxes due to the COVID-19 disaster emergency;

WHEREAS, Monroe Township has determined that it is in the best interests of the Township, its residents and taxpayers for the Township to provide relief to those paying taxes on the assessed value of real property located within the Township.


NOW, THEREFORE, BE IT RESOLVED, with the intent to be consistent with the Cumberland County Board of Commissioners Resolution 2020-14, Monroe Township hereby waives any penalties associated with the late payment of the tax imposed on the assessed value of real estate which are due in calendar year 2020, provided that the tax is paid in its entirety by October 31, 2020. Commencing on November 1, 2020, the penalty rate of ten per centum (10%) shall be assessed. Any late fees paid prior to the date of this Resolution shall not be subject to a refund.






