RESOLUTION NO. 2020-09

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF
THE TOWNSHIP OF MONROE, CUMBERLAND
COUNTY, PENNSYLVANIA, ESTABLISHING A SEWER
RESERVATION CAPACITY FEE**

WHEREAS, upon recommendation of the Monroe Township Sewer Authority (hereinafter referred to as the “Authority”), the Monroe Township Board of Supervisors (hereinafter referred to as the “Board of Supervisors”) desires to adopt a sewer reservation capacity fee.

WHEREAS, the purpose of this Resolution is to establish the reservation fees for the Northern and Southern sewer districts of Monroe Township.

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the Township of Monroe, Cumberland County, Pennsylvania, as follows:

Section 1. Fees.

1. The Sewer Reservation Capacity fee for the Northern District shall be \$100.00 per quarter per Equivalent Dwelling Unit (EDU).
2. The Sewer Reservation Capacity fee for the Southern District shall be \$100.00 per quarter per Equivalent Dwelling Unit (EDU).
3. The Sewer Reservation Capacity fee is separate from a connection fee. The amount paid for a connection shall be the amount in effect at the time of connection. At the time of connection, no refund of the Sewer Reservation Capacity fee shall be due.

Section 2. Term of Reservation.

Reservations granted by the Board of Supervisors shall be for a term of one (1) year.

Section 3. Discretion of Board of Supervisors.

The granting of reservation of sewer capacity shall be made at the discretion of the Board of Supervisors based upon availability of capacity, economic conditions and other factors as determined by the Board of Supervisors.

Section 4. Repealer.

All other Resolutions, or parts of Resolutions inconsistent herewith shall be and the same expressly are repealed.

Section 5. Amendments.




This Resolution may be amended by the Board of Supervisors from time to time based upon the advice of the Township Engineer.

Section 6. Effective Date.


This resolution shall take effect immediately upon passage.
