**RESOLUTION 2016-24**

**RESOLUTION ESTABLISHING THE CURRENT STREET  
LIGHT ASSESSMENT RATES AND AUTHORIZING  
CUMBERLAND COUNTY TO PREPARE THE  
BILLING STATEMENTS THEREFORE**

WHEREAS, the Board of Supervisors of Monroe Township by Resolution No. 87-5, enacted December 22, 1987, established certain assessment rates for street lights; and

WHEREAS, Monroe Township is desirous of contracting with Cumberland County to have the County prepare the billing statements for the street light tax; and

WHEREAS, this Resolution and the objections leading to its enactment are authorized by "The Second Class Township Code", Act of May 1, 1933, P.A. 103; Act of July 10, 1947, P.S. 1481, as amended by Act 60 of 1995 (53 P.S. Section 2001, et seq.).

NOW, THEREFORE be it resolved by the Board of Supervisors of Monroe Township, Cumberland County, Pennsylvania, as follows:

1. Effective January 1, 2017 the assessment rate for street lights will be as follows:

SEATED AREA – Forty-eight (\$.48) cents per front foot.


UNSEATED AREA – Twelve (\$.12) cents per front foot.

2. Cumberland County is hereby authorized to prepare the billing statements for the street light tax utilizing the following methods for payment: two (2%) percent discount if the street light tax is paid during the first two (2) months; face value payment for a two (2) month period; ten (10%) percent penalty to be added after four (4) months.

3. The Secretary of Monroe Township is directed to compute any and all necessary assessments for street lighting within Monroe Township and shall file same, along with a true and correct copy of this Resolution, with the Monroe Township Tax Collector and with Cumberland County.
